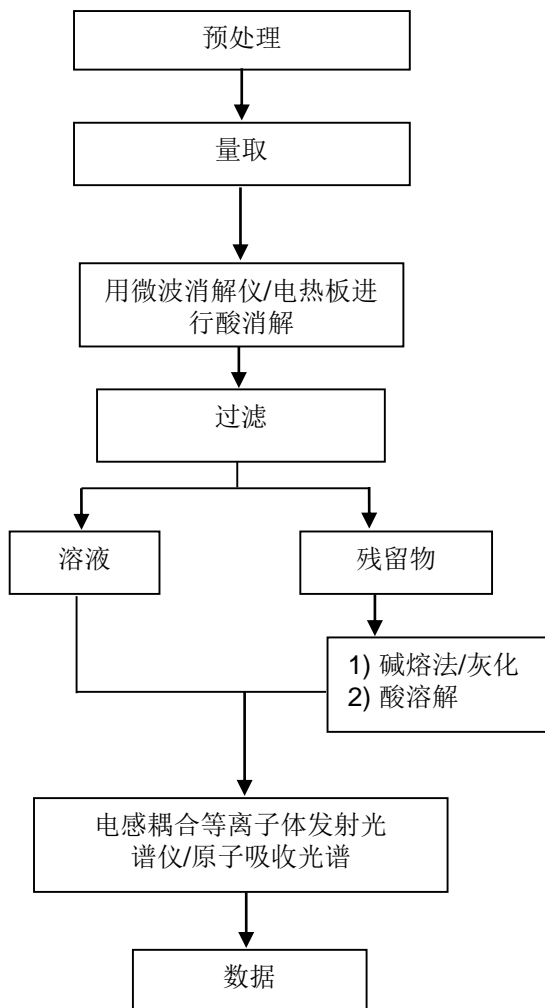

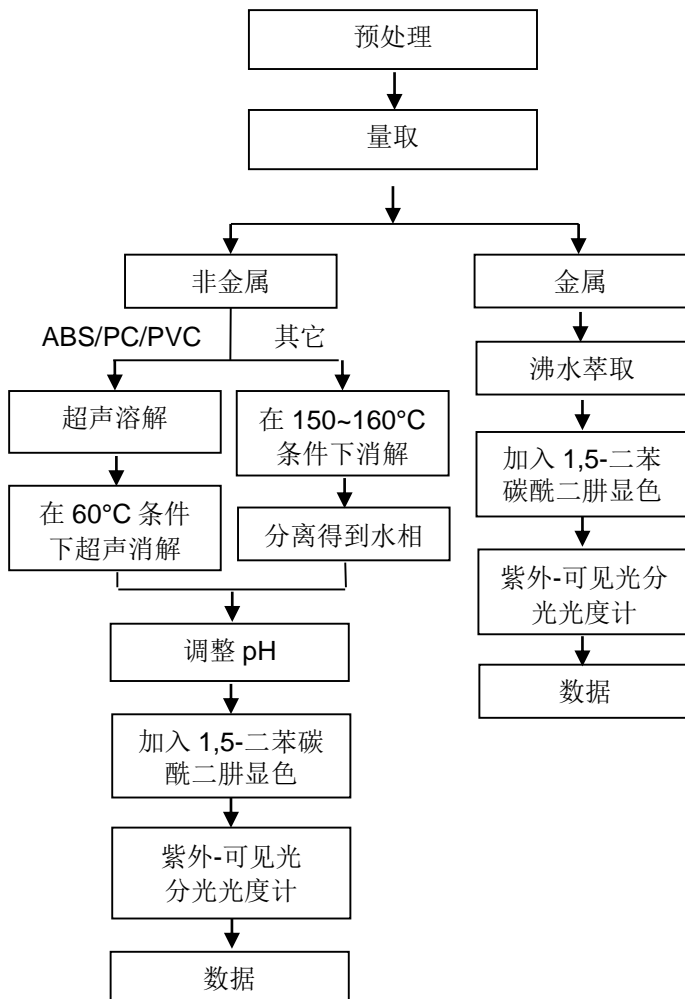

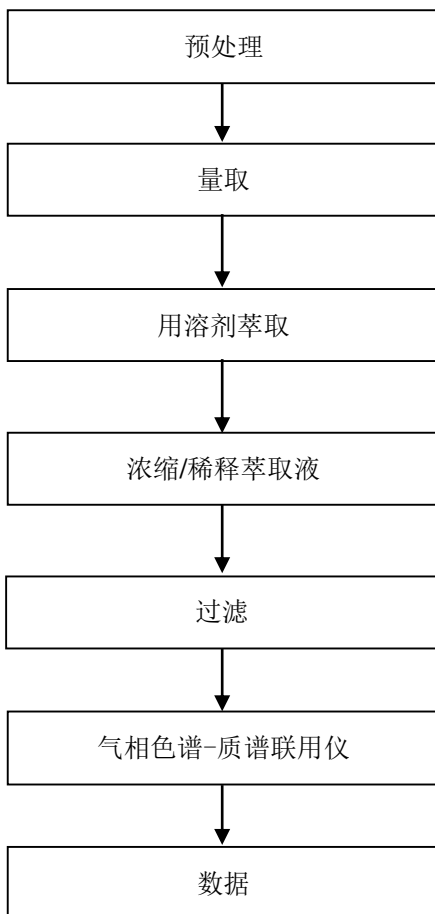

PBB/PBDE 检测流程图



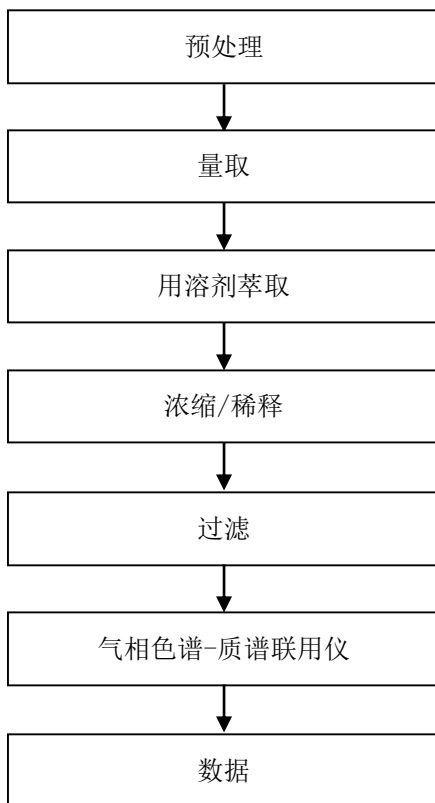

Phthalates 检测流程图



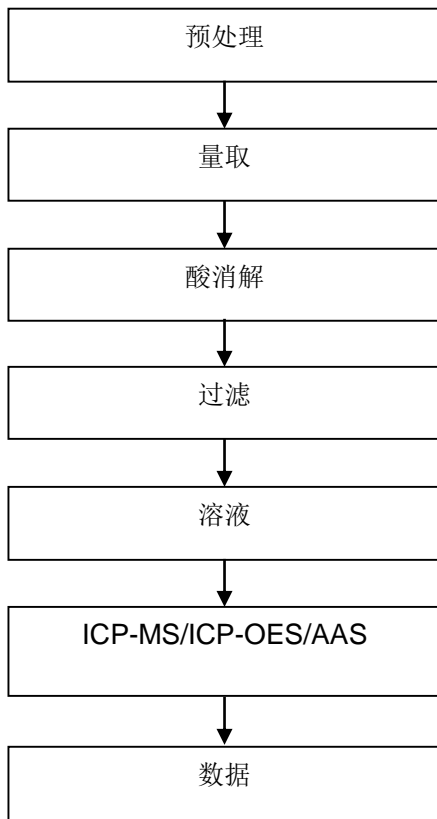

元素检测流程图



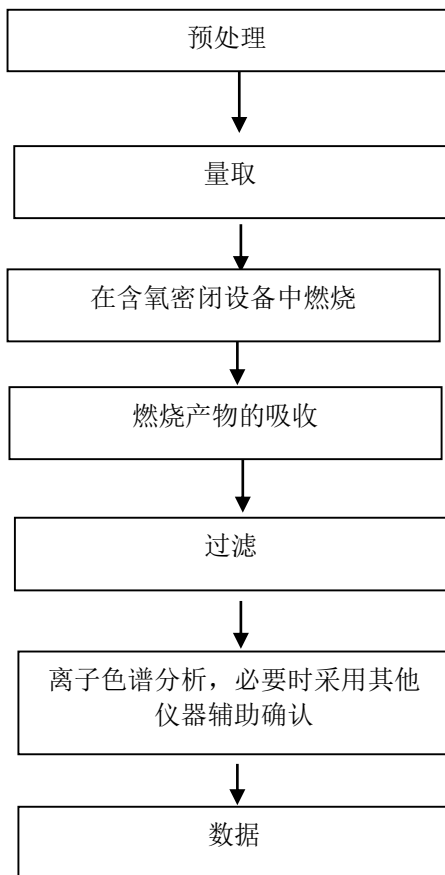

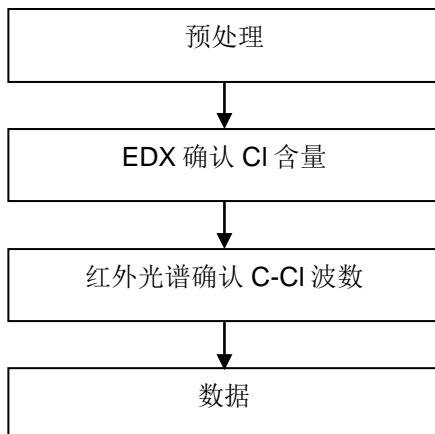
